III. STATEMENT OF ISSUES

At issue is whether the Court should grant the Petitioner an Order recognizing the medical change of gender and gender marker of the Petitioner.

IV: EVIDENCE RELIED UPON

This Petition relies upon the evidence included in the Statement of Facts made by the Petitioner and the information included in the medical letter provided by the Petitioner.

V. AUTHORITY AND ARGUMENT

1. <u>Authority to Grant Gender Marker Change</u>: RCW 2.08.010 empowers the Washington Superior Courts to have jurisdiction to hear "such special cases and proceedings as are not otherwise provided for" for the residents of the county in which they preside. This hearing is this type of special case which is not otherwise provided for in the state rules. Washington state primarily addresses gender and gender marker changes through administrative processes with the Department of Licensing. To update gender identity information on a state issued ID, a person must provide a medical certification and update form to the Department of Licensing. To update gender on a birth certificate, a person must complete a form from Vital Statistics.

The acceptable administrative standard for gender change in Washington state is a certification from a medical provider or counselor that the person has undergone appropriate clinical treatment for a change of gender. The Petitioner has completed all necessary treatment to qualify for a gender change under these administrative procedures.

A court order is not needed in Washington for a resident to receive a change of gender and gender marker. However, in the situation of the Petitioner, obtaining such a court order would further facilitate the Petitioner's ability to obtain corrected identity related documents which require such an Order as well as a corrected Passport. Local Superior Court Judges are the only authority which can issue such Gender Change Recognition Orders.

2. <u>No Prohibition</u>: Washington law does not prohibit the court from issuing an order which recognizes a Petitioner's change of gender and gender marker.
